LISTED BUILDING ENFORCEMENT NOTICE

ISSUED BY: THE LONDON BOROUGH OF CAMDEN

1. **THIS IS A FORMAL NOTICE** which is issued by the Council being the Local Planning Authority for the purposes of Section 38 of the above Act because it appears to them that there has been a contravention of Section 8 of the Act, in respect of the building within a conservation area described below. The Council considers it necessary to issue this notice for the reasons set out in paragraph 4 below.

2. **THE LISTED BUILDING**

Land at: 52 Stanhope Street, London, NW1 3EX as shown outlined in black on the attached plan (“the Property”).

3. **THE CONTRAVENTION ALLEGED**

Without listed building consent: Installation of a partition in the first floor front room.

4. **REASONS FOR ISSUING THIS NOTICE**
 - a) The work outlined above has been carried out to this Grade II listed building without the benefit of Listed Building Consent.
 - b) The installation of a modern partition subdividing the front room has adversely impacted on the spatial proportions of the room in which it has been installed, resulting in harm to the special architectural and historic character of the listed building and the legibility of the historic floorplan, contrary to policies D1 and D2 of the London Borough of Camden Local Plan 2017.

5. **WHAT YOU ARE REQUIRED TO DO**

Within a period of **THREE (3) months** of the Notice taking effect:

1. Completely remove the modern partition in the first floor front room.

6. **WHEN THIS NOTICE TAKES EFFECT**

This notice takes effect on **14 NOVEMBER 2019** unless an appeal is made against it beforehand.

You can appeal against this notice, but any appeal must be received, or posted in time to be received, by the Secretary of State by **14 November 2019**.

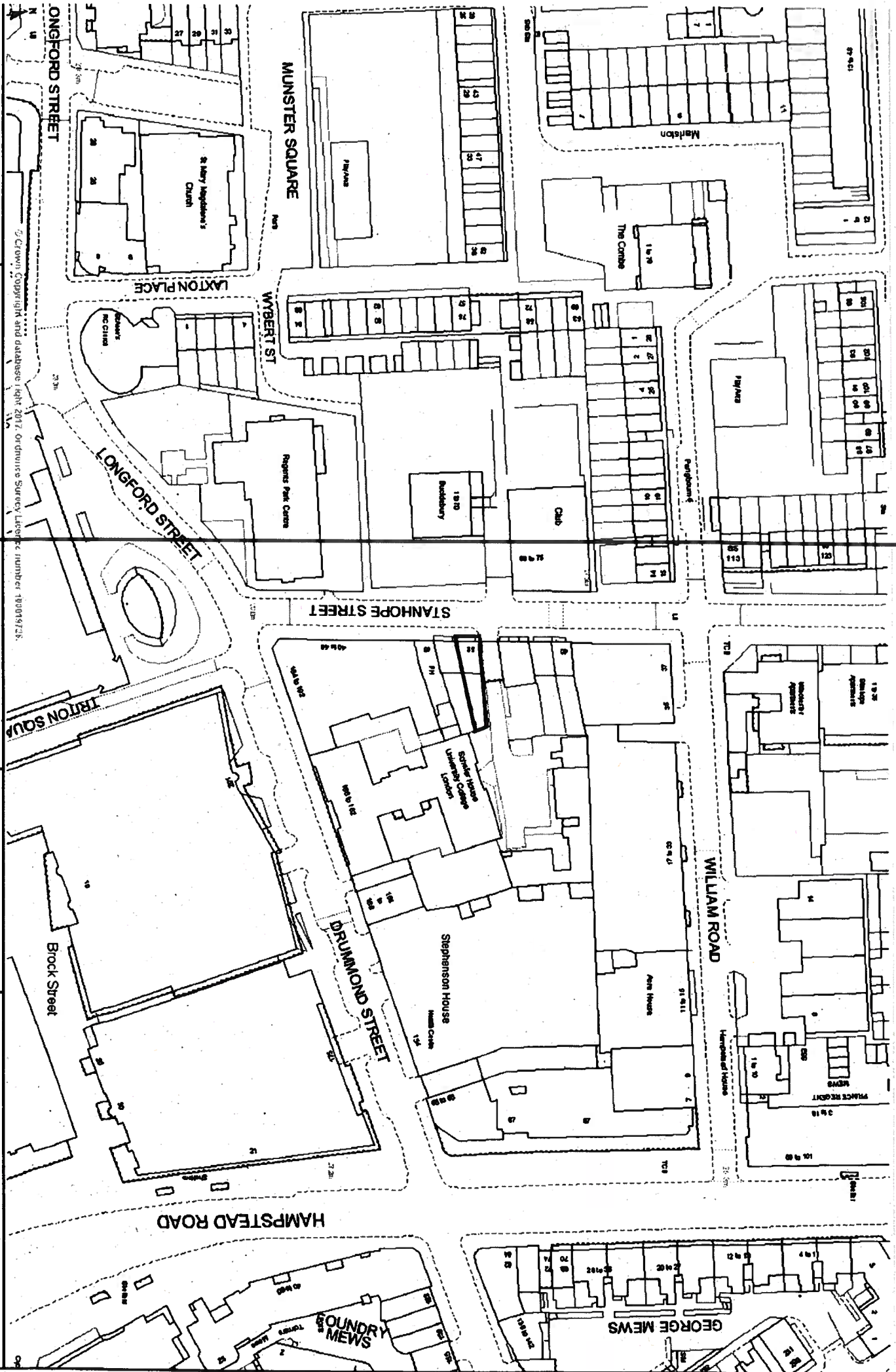
- (a) Send a copy of your appeal to the Secretary of State if you decide to appeal, together with a copy of this enforcement notice.
