Installation of gate and metal stair from street to basement level in front light well. Drawing Nos: 572 01, 416.04, 572 02, 572 20 B, Design and Access Statement dated August 2019

The Council has considered your application and decided to grant permission subject to the following condition(s):

Condition(s) and Reason(s):

1 The development hereby permitted must be begun not later than the end of three years from the date of this permission.

Reason: In order to comply with the provisions of Section 91 of the Town and Country Planning Act 1990 (as amended).

All new external work shall be carried out in materials that resemble, as closely as possible, in colour and texture those of the existing building, unless otherwise specified in the approved application.

Reason: To safeguard the appearance of the premises and the character of the immediate area in accordance with the requirements of policy D1 and D2 of the London Borough of Camden Local Plan 2017.

The development hereby permitted shall be carried out in accordance with the following approved plans: 572 01, 416.04, 572 02, 572 20 B, Design and Access Statement dated August 2019

Reason: For the avoidance of doubt and in the interest of proper planning.

Informative(s):

1 Reasons for granting permission.

The installation of a gate in the existing front lightwell railings is considered to represent a minor intervention that would not cause harm to the significance of the listed building. Similarly, the proposed metal staircase would appear as a lightweight addition that would run across the front of the property at lower ground floor level and would not interfere with any of the buildings historic features. Furthermore, the proposed gate would be created by adapting the existing railings, rather than removing a section of them, ensuring no loss of historic fabric would occur as a result of the development. The existing eight over eight single glazed sash window would be retained and refurbished as necessary whilst the entrance door would be upgraded in single glazing, which is welcomed.

The proposed alterations would match those of several neighbouring properties in the street which have introduced gated access at ground floor level with metal steps leading down to lower ground floor level. As such, the proposals are not considered to cause no harm to the character and appearance of the surrounding conservation area.

The proposals would not have a significant impact on neighbouring amenity in terms of loss of light, outlook or privacy.

No objections were received following statutory consultation. The planning history of the site and surrounding area were taken into account when coming to this decision.

Special regard has been attached to the desirability of preserving the listed building and its features of special architectural or historic interest, under s.66 of the Planning (Listed Buildings and Conservation Areas) Act 1990 as amended by the Enterprise and Regulatory Reform Act (ERR) 2013.

Special regard has also been attached to the desirability of preserving or enhancing the conservation area, under s.72 of the Planning (Listed Buildings and Conservation Areas) Act 1990 as amended by the Enterprise and Regulatory Reform Act 2013.

As such, the proposal is in general accordance with Policies D1, D2 and A1 of the Camden Local Plan 2017. The proposed development also accords with

the policies of the London Plan 2016 and National Planning Policy Framework 2019.
