e.g. Oak (T3) - fell because of excessive shading and low amenity value. Replant with one standard ash in same position.

T1 - Large Holly covered in ivy - Fell to ground level to regrow as a hedge.

T2 - Fig tree – Coppice to stump level to re-grow.

T3 - Eucalyptus – Reduce back overhang by 3m so it scarcely overhangs the wall. T4 - Ash tree – Sever ivy and pollard tree to 3 inch cuts for easier future maintenance of pollard heads.

All work required due to excessive growth into neighbouring property on Netherall Gardens.
