## Core Campus Works –Wilkins Building, University College London

## Application to Discharge Condition 4 pursuant to 2019/0067/L

On behalf of our Client, University College London ('UCL'), please find enclosed an application to discharge Condition 4 pursuant to 2019/0067/L at the Cloisters in the Wilkins Building, University College London ('the Site'). Planning Permission and Listed Building Consent was granted on 18 September 2019 for:

"Internal alterations to create a new internal opening, doorway and access route between Wilkins building south cloister, Bernard Katz building and Japanese garden."

This application seeks to discharge Condition 4 of the Listed Building Consent (2019/0067/L) only.

### Condition 4

Condition 4 of the Listed Building Consent (ref. 2019/0067/L) states:

"No opening up works to the rear elevation shall occur until full details of the relocation of the wooden cabinet accommodating Jeremy Bentham's model/case and of its associated plaque to a publicly accessible area of the UCL main campus have been submitted to and approved in writing by the local planning authority. Such details shall include an annotated plan showing the new location. The outer wooden cabinet used to accommodate Jeremy Bentham's model/case and the associated wall plaque shall thereafter be relocated and retained in accordance with the approved details unless otherwise approved in writing by the local planning authority."

Following the approval of the application, a meeting was held with the Conservation Officer on 13 November 2019 and it was agreed that the details submitted pursuant to this condition could include more than one suitable location for the cabinet. This application includes details of two locations for the cabinet, both of which are located within the Cloisters of the Wilkins Building, in a publicly accessible location.
