## **Executive Summary**

- Allen Archaeology Limited was commissioned by Chan and Eavrs to prepare a desk-based assessment to evaluate the archaeological potential of 111 Frognal, Hampstead, within the London Borough of Camden, in advance of the submission of a planning application for an extension to the existing building.
- Data was gathered from a range of primary and secondary sources, including the Greater London Historic Environment Record, Camden Archives, historic maps, online resources and a site visit. The archaeological potential for the proposed development site is considered low to moderate. The GLHER record no prehistoric or early medieval remains in proximity to the site and only limited Roman evidence.
- The assessment has found previously recorded evidence of medieval domestic features, with recorded activity such as finds scatters, cess pits and structural evidence noted in close proximity to the site. Part of the site to the east is within the Hampstead Archaeological Priority Area relating to the former medieval settlement.
- Later features associated with the formal gardens shown on 18<sup>th</sup> and 19<sup>th</sup> century mapping may also survive, although the summer house appears to have been located to the south of the site boundary. These are part of the Frognal Grove manor house and surrounding gardens and estate, built by Henry Flitcroft during the mid-18<sup>th</sup> century. The present dwelling at 111 Frognal is formed from the former stables of Frognal Grove. The site has seen a number of changes, alterations and demolitions since they were constructed in the 18<sup>th</sup> century. The most recent of these were the extension of the stable block by the mid-19<sup>th</sup> century and then more substantial renovations in the mid-20<sup>th</sup> century.
- The development proposals are for a garden basement and new extension, with the extension sitting above the proposed basement. The proposals have been carefully designed to remove harm to the Flitcroft 18<sup>th</sup> century stable building, focussing on the 1960s extension facades and have utilised pre-existing lightwells and areas of disturbance for the garden basement.
- Consequently, as a result of these careful designs, the proposed development has negligible potential to impact on archaeological remains within the site. The works are within areas previously disturbed, either through the 20<sup>th</sup> century amendments or from the demolition of earlier fabric and replacement during the 1960s.
- Therefore, the assessment has deemed that no further archaeological work is necessary although the final decision lies with the Greater London Archaeological Advisory Service.

## 1.0 Introduction

- 1.1 Allen Archaeology Limited (hereafter AAL) was commissioned by Chan and Eayrs to prepare a desk-based assessment to evaluate the archaeological potential of 111 Frognal, Hampstead, NW3 6XR, London Borough of Camden, in advance of the submission of a planning application for extension of residential building.
- 1.2 The document has been completed with reference to current national guidelines, as set out in the Chartered Institute for Archaeologists 'Standard and guidance for historic environment desk-based assessment' (CIFA 2014), and the Historic England documents 'Management of Research Projects in the Historic Environment' (Historic England 2015a), 'Historic Environment Good Practice Advice in Planning' (Historic England 2015b) and the GLAAS 'Guidelines for Archaeological Projects in Greater London) (GLAAS 2015).

## 2.0 Site Location and Description

- 2.1 The proposed development site is located at 111 Frognal, Hampstead, in the administrative district of the London Borough of Camden. It is situated *c*.7km northwest of central London and *c*. 2.5km northwest of Camden Town. The site is approximately *c*.0.14 hectares and is presently occupied by a dwelling with associated garden and tool shed. The site is centred at National Grid Reference TQ 2612 8594 and is *c*.118m above Ordnance Datum.
- 2.2 The bedrock geology comprises Bagshot Formation Sand which is Sedimentary Bedrock formed approximately 48 to 56 million years ago in the Palaeogene Period, with no superficial geological deposits recorded (http://mapapps.bgs.ac.uk/geologyofbritain/home.html).
- 2.3 The site is some distance to the north of the recorded extent of the River Terrace Gravels associated with the Palaeolithic route of the River Thames, the nearest of which are recorded south of Regents Park, *c*.4km to the south.

# 3.0 Planning Background

3.1 This archaeological desk-based assessment has been prepared to inform a planning application that will be submitted in due course for an extension to the existing dwelling. This is the first stage of archaeological investigation, intended to provide detailed information that will allow the planning authority to make an informed decision as to whether further archaeological investigations will be required prior to or following the determination of a planning application for the proposed development.

## National Planning Policy

- 3.2 The revised National Planning Policy Framework (NPPF) was published in February 2019 (Ministry of Housing, Communities and Local Government 2019).
- 3.3 The relevant sections of the NPPF (Department for Communities and Local Government 2018) concerning archaeological and cultural heritage assets, are Paragraphs 187 and 189 of *Section 16. Conserving and enhancing the historic environment'*. Paragraph 189 has special relevance concerning the responsibilities of planning applicant:

'In determining applications, local planning authorities should require an applicant to describe the significance of any heritage assets affected, including contribution made by their setting. The level of detail should be proportionate to the assets' importance and no more than is sufficient to understand the potential impact of the proposal on their significance. As a minimum the relevant historic environment record should have been consulted and the heritage assets assessed using appropriate expertise where necessary. Where a site on which development is proposed includes or has the potential to include heritage assets with archaeological interest, local planning authorities should require developers to submit an appropriate desk-based assessment and, where necessary, a field evaluation'.

# Local Planning Policy

- 3.4 The Hampstead Neighbourhood Plan was adopted by the Hampstead Neighbourhood Forum from October 2018 (Hampstead Neighbourhood Forum, 2018). In accordance with NPPF paragraph 216, the policies contained within the emerging plan will be used alongside current development plans in determining the outcome of planning applications.
- 3.5 The relevant policies of The Hampstead Neighbourhood Plan (Hampstead Neighbourhood Forum, 2018) concerning archaeological and cultural heritage assets are DH2:

Policy DH2: Conservation areas and listed buildings

- 1. 'Planning applications within a Conservation Area must have regard to the guidelines in the relevant Conservation Area Appraisal(s) and Management Strategies.
- 2. In reference to NPPF paragraphs 131 to 136, the Plan provides further guidance on the application of these policies below.
- 3. New development should take advantage of opportunities to enhance the Conservation Areas by protecting and, where appropriate, restoring original architectural features, including walls, windows, doors, etc., that would make a positive contribution to the Conservation Areas.
- 4. Development proposals must seek to protect and/or enhance buildings (or other elements) which make a positive contribution to the Conservation area, as identified in the relevant Conservation Area Appraisals and Management Strategies (see Appendix 3).'

## 4.0 Methodology

## Data Collection

- 4.1 A full range of primary and secondary archaeological and historical sources were consulted in the preparation of this document. The sources consulted were as follows:
  - Greater London HER (GLHER) a database of archaeological sites and artefacts, listed buildings and Scheduled Monuments. A search of this resource was undertaken for a study area extending 500m from the centre of the site.

- Camden Local Studies and Archives Centre holds a range of historic maps, for example enclosure maps, Tithe maps, estate plans, and former editions of Ordnance Survey maps of the development area.
- Allen Archaeology's own reference library secondary sources pertaining to the archaeology and history of the region.
- A site visit was carried out on 7<sup>th</sup> of November 2019 in order to assess the present situation of the development area, to identify any areas where the potential archaeological resource may be particularly well preserved or damaged by recent development, and to observe the site in its landscape context.
- 4.2 Each archaeological and historic site and Listed Building identified in the study area has been allocated a one or two digit 'Site' number and assigned to a specific period according to the definitions outlined on the English Heritage Periods List (formerly the Royal Commission on the Historical Monuments of England (RCHME) Archaeological Periods List). These sites are described in the Archaeological and Historical Background section (See Section 5.0 below). Further details are provided for each site in Appendix 1, and where applicable the sites are depicted on Figure 3 and Figure 4.

# 5.0 Archaeological and Historical Background

## GLHER monuments & historic mapping

- 5.1 Prehistoric remains dating from the Palaeolithic period have been recorded within the search area, with a pointed hand axe (ficron) recorded *c*.300m southeast of the site in 1897 (Site 1), which would broadly tally with the nearest River Terrace Gravels denoted on the BGS mapping. A Mesolithic tranchet-style axe has also been recorded *c*.350m southwest of the site, found in a residential garden (Site 2). Possible prehistoric earthworks may have been identified *c*.460m north of the site, although limited information is available on the exact nature of these features (Site 3). A small portion of an Archaeological Priority Area (APA) relating to 'West Heath Mesolithic Site' is located *c*.470m northwest of the proposed development site, however no archaeology associated with the APA has been recorded within the search area, with the Mesolithic tranchet axe found to the southwest (Figure 10).
- 5.2 No later prehistoric archaeological activity is know from the study area.
- 5.3 Roman archaeology within the search area comprises part of a ceramic rim *c*.30m southwest of the site boundary (Site 4), two glass beads *c*.310m southeast of the site (Site 5), and two potsherds found *c*.170m southeast of the site dating to *c*.300 AD, with these latter Roman finds recovered with post-medieval features and thus may be residual (Site 6).
- 5.4 There is no physical evidence for early medieval activity in the study area. However, a charter of 968 AD records a manor in Hampstead gifted to the monastery of St Peter in Westminster by King Ethelred. THE GLHER locates the historic village centre (Site 7) c.280m southeast of the site and this area is defined as an APA. Hampstead is also mentioned in the Domesday Book of 1086 as being worth a total of 55s prior to the Norman Conquest in 1066 (Williams and Martin 2002).

- 5.5 Following the Conquest, Hampstead was held by two lords of the manor; the Abbot of St Peter's and Ranulph Peverel, with the recorded resources comprising ploughland and woodland for 100 pigs, with just seven households recorded, suggesting the settlement was small and largely agrarian. A church is referenced in documentary evidence *c*.390m southeast of the site, off Church Row, although its absence from the Domesday entry suggests the building post-dates 1086 (Site 8).
- 5.6 The Archaeological Priority Area summary for Hampstead suggests that as late as the 12<sup>th</sup> century it appears to have been a small farmstead with development increasing from the late 13<sup>th</sup> century. The Victoria County History suggests historically the settlement was seen as a place useful to visit to escape natural disasters including plagues and floods between the 14<sup>th</sup> and 17<sup>th</sup> centuries.
- 5.7 Archaeologically the medieval period is fairly well represented, including a patterned floor surface c.190m east of the site (Site 9) identified in a house dating to the 17<sup>th</sup> century. A lead bulla c.370m southeast of the site (Site 10), a 'costrel' flask c.220m southeast of the site (Site 11) and a lead token, c.290m southeast of the site (Site 12) were all identified during the 19<sup>th</sup> century, and as such information on their exact provenance and location may be not 1000% accurate. Modern archaeological evaluations have recorded medieval pottery at three sites (Sites 13–15) including in a cess pit feature c.90m southeast of the site (Site 14), suggestive of settlement activity in proximity to the site. The eastern portion of the site is also included within the 'Hampstead' APA, covering the growth of the medieval settlement.
- 5.8 In addition to the archaeological remains, several streets are believed to have originated during the medieval period (Sites 16–20). Based on early post-medieval mapping it is likely that the medieval road layout has survived in later periods, including part of Branch Hill running close to the site boundary. The nature of post-medieval enclosure within Hampstead appears has been described as 'haphazard' (VCH 1989: 15–33), with the terrain and nature of the enclosure explaining the 'bizarre' (*ibid*) street pattern and the prevalence of squares.
- 5.9 By the end of the medieval period and moving into the post-medieval period Hampstead increased in wealth as many of the tenements passed into the ownership of London's merchants and gentry. During this period, many of the timber-framed medieval buildings were replaced by brick built structures (VCH 1989).
- 5.10 By the 17<sup>th</sup> century Hampstead was predominantly cottages besides the original manor farm, with regular housing developing along the High Street. An increase in the number of inns has also been recorded in keeping with the increasing local population and Hampstead's popularity, based on a perceived health benefits of living outside of central London (VCH 1989).
- 5.11 Undesignated heritage assets of post-medieval date recorded in the study area comprise a medical college *c*.120m east of the site (Site 21) and hospital ward *c*.290m east of the site (Site 22), as well as a workhouse *c*.70m southeast of the site (Site 25) and Manor House *c*.420m south of the site (Site 27). The GLHER also includes wall footings *c*.90m south of the site (Site 30), a timber structure which was replaced by a brick building *c*.100m southeast of the site (Site 31), and at least one building with a cellar *c*.410m south of the site (Site 33). Several dumps of waste material, including pottery and food waste have also been identified in the study area (Sites 36–39).

- 5.12 John Rocque's map of 1746 (Figure 5) shows the approximate area of the site being occupied by what appears to be a planned garden of some kind with a building located to the south, outside of the boundary of 111 Frognal. The slightly stylised nature of Rocque's maps suggests gardens or orchards although it could be any form of cultivated land.
- 5.13 By 1762 (Figure 6) mapping indicates the presence of a building within the site boundaries, along with an increased level of building in the surrounding area. This corresponds with the 18<sup>th</sup> century stable block designed by Henry Flitcroft, who designed and built Frognal Grove in 1750, with the main house to the south. A second building is shown to the rear of the stable block and may be the summerhouse. The map also appears to show a tree lined avenue aligned north-south running parallel to Frognal. The document accompanying the map gives the following details:
  - 418 The dwelling house of and belonging to Henry Fleetcroft [sic] esq with forecourt and large garden
  - 419 The coach house with stabling and other outhouses yards and necessary also a garden and summer house therein
  - 420 The paddock or orchard adjoining
- 5.14 The 1866 Ordnance Survey map (Figure 7) shows the site and stable block in considerably more detail, occupying an area of landscaped grounds comprising a garden with curving path, a range of outbuildings extending north of a large house, and an access path to the front of the same house. The possible summerhouse had been removed and replaced by what is possibly landscaped gardens.
- 5.15 The later 1893 OS map is broadly unchanged (Figure 8) but shows an earthwork bank on the eastern edge of the site. The built environment appears unchanged.
- 5.16 During the modern period the only non-designated asset is a convalescent home for Anglo-Jewish patients *c*.290m northeast of the site, used as an auxiliary hospital during the First World War (Site 40).
- 5.17 Ordnance Survey mapping dating to 1935 (Figure 9) shows the site as almost unchanged from 1893, with the exception of an area of earthworks shown on the western edge of the site. The dwelling immediately south of the site is annotated as Frognal Grove.
- 5.18 One GLHER entry of uncertain date and function has been identified, a steep sided cut or side of a ditch, sealed by modern made ground *c*.400m southeast of the site (Site 41).

## **GLHER** Parks

- 5.19 There are ten parks recorded in the HER (PK), ranging in date from the early medieval period through to the post-medieval.
- 5.20 The earliest, early medieval example refers to an apparent 10<sup>th</sup> century churchyard *c*.380m southeast of the site, now associated with an 18<sup>th</sup> century church (Site 42).
- 5.21 Hampstead Heath, *c*.490m northeast of the site is listed with a medieval date due to it being enclosed in 1227, with a boundary feature referred to as the Great Ditch (Site 43).
- 5.22 Post medieval-parks include Burgh House *c*.490m east of the site (Site 44) and Fenton House *c*.170m northeast of the site (Site 45) that are both historic houses including substantial

grounds including gardens and orchards. An extension to St John's church graveyard *c*.270m southeast of the site, was consecrated in 1812 as additional burial space was deemed necessary (Site 46). Two gardens (Sites 47–48) *c*.150m northwest and *c*.400m northeast respectively have also been identified including areas of woodland, allotments and open grass. Three public squares have also been designated under the London Squares Preservation Act of 1931, all dating to the post-medieval period *c*.440m east, *c*.22m east of the site and *c*.150m east of the site respectively (Sites 49–51).

## **GLHER Listed Buildings**

- 5.23 There are 275 Listed Buildings within the search area, dating from the 17<sup>th</sup> (Sites 52–61), 18<sup>th</sup> (Sites 62–206) and 19<sup>th</sup> centuries (Sites 207–307). The overwhelming majority of these Listed Buildings are residential in nature along with associated structures including walls and gate piers, with burial monuments also being well represented.
- 5.24 Of particular note are the Grade II Listed properties Listed under Nos. 105–111 (Site 110) along with associated garden walls, railings, etc. (Site 23), and including the proposed development site. No. 111 Frognal was initially a stable block in the 18<sup>th</sup> century with later extensions and alterations from at least the mid-19<sup>th</sup> century onwards. The site is located within the grounds of Frognal Grove, was subdivided into smaller plots during the mid-20<sup>th</sup> century after the 1935 Ordnance Survey map was produced, although the building appears to have remained on the same footprint, albeit with alterations.
- 5.25 There are also 18 modern Listed Buildings (Sites 308–325), and six bollards which are included in the HER as undated but are also of modern date (Site 326).

## 6.0 Site Visit

- 6.1 The site was visited by Michał Górzyński on 7<sup>th</sup> of November 2019. Selected photographic images taken during the site visit are reproduced below and their locations indicated on Figure 2.
- 6.2 The development site is broadly sub-rectangular, measuring *c*.0.12ha and sloping from west to east in a sharply declining gradient comprising an approximately rectangular house with steps up from the house and garden. The development area is bordered to the north, west and south by residential development and to the east by internal access road to houses No. 105, 107, 109, 111, 113 and 115 Frognal.

6.3 All of the houses including numbers 105 and 111 at Frognal Grove are Grade II\* Listed Buildings and are physically connected in the manner of a terrace.

6.4 At the front of the house there is a cobbled yard area with a tool shed next to the east boundary wall.

6.5 There is limited intervisibility between the proposed development site and buildings located at the southeast side of Frognal.

6.6 During the site visit no evidence for archaeological features were noted within the site.

## 7.0 Assessment of Significance

7.1 The following assessment of the heritage value of the heritage assets within the search area is based upon values recognised by Historic England and an analysis and understanding of the historical development of the site, including all available documentary and physical evidence. The assessment also considers more intangible values, such as historical or social associations (where applicable), to help establish the overall level of importance of the proposed development area as a place of cultural heritage. Each heritage asset will be assessed using the following categories of significance:

7.2 There are no World Heritage, Registered Battlefields, Registered Parks and Gardens or Scheduled Monuments within the search area.

## **GLHER Monuments and Historic Mapping**

- 7.3 Previously recorded prehistoric archaeology within the search area is fairly limited in scope, comprising two artefacts and some possible earthworks, potentially separated by thousands of years. The limited scope of the prehistoric archaeology within the search area is considered to limit its significance, with two isolated finds of limited evidential value.
- 7.4 Roman monuments within the search area are also limited to a small number of pot sherds and are considered to lack significance for the same reasons. The presence of a rim sherd close to the southern border of the site, on its own is of little value but it may indicate the potential for further activity of this date.
- 7.5 Physical evidence of early medieval date is entirely absent within the search area although documentary and place-name evidence may suggest some form of pre-Conquest habitation or exploitation. However, there is no indication of this within the site area and thus there is no apparent value.
- 7.6 Medieval archaeology has been noted in the eastern half of the search area, with a particular concentration to the southeast and south of the site between Frognal and Greenhill. Based on the presence of a pottery dump and a cess pit in close proximity to the site, and the site's partial inclusion within the APA, the medieval archaeology is considered to have some historic and evidential value regarding the extent and nature of medieval settlement in Hampstead, but limited communal and aesthetic value.
- 7.7 The post-medieval monuments included within the HER are varied in nature, including buildings and some archaeological records. As a result the post-medieval archaeology and historic buildings are considered to hold some historic and evidential value based on the information and extant fabric relating to vernacular building traditions, and the relationship between increased development and the rise in the number of brick built buildings throughout the post-medieval period. Given the majority of the buildings recorded in the

GLHER are no longer extant, this limits the main surviving significance stems to their historic and evidential value.

## HER Parks

7.8 The parks predating the post-medieval period are the 10<sup>th</sup> century churchyard (now in association with an 18<sup>th</sup> century church) and the medieval enclosure of Hampstead Heath. They both offer some historic and evidential value based on their being a tangible connection to the history of Hampstead and the development of the settlement, with the churchyard holding additional aesthetic and communal value based on its continued function as a local churchyard and Hampstead Heath holding communal value based on the number of visits and the utility of the land.

## HER Listed Buildings

- 7.9 The Listed Buildings within the search area date to between the 17<sup>th</sup> century and the modern period encompassing a wide range of building types including houses, burial monuments, lamp posts and telephone kiosks. As a whole the Listed Buildings offer historic and evidential value based on the survival of historic fabrics, and aesthetic and communal value based on the fossilisation of particular aspects of Hampsteads history, in particular (but not exclusively) the increase in housing reflecting an increased population. The burial monuments also offer a high degree of communal value in addition to their historic and evidential value relating to prior residents of Hampstead.
- 7.10 Of particular note is the site itself, comprising part of a group of Listed Buildings. The buildings offer historic and evidential value relating to vernacular architecture, having been developed from a stable block in the 18<sup>th</sup> century, and with subsequent alterations. While No. 111 is not considered part of the 'Principal House', its history and association is fairly well understood and mapped. The communal value is somewhat limited due to the house being in private ownership, however the aesthetic value relating to the development of Hampstead and Frognal Grove is apparent.

# 8.0 Assessment of Impact

## **Development Proposals**

- 8.1 The proposed development comprises a garden basement and upper ground rear extension (Figure 11, Figure 12).
- 8.2 The proposed basement will be built within an existing cut, alongside the existing lightwell, therefore alleviating the need for additional ground disturbance or excavation. The existing façade of the building is part of the 1960s extension and thus no historic 18<sup>th</sup> century fabric will be exposed or affected.
- 8.3 The proposed rear extension will be sited above the backfilled garden and no excavation of previously undisturbed ground will occur as part of this aspect of the development proposals. The extension will join in with the 1960s extension and no historic 18<sup>th</sup> century fabric will be affected.

## HER Monuments and Historic Mapping

8.4 The proposed development is anticipated to have minimal impact on any potential remains relating to the historic gardens. The historic mapping suggests that the proposed works will not encounter the summer house or other elements of the Frognal Grove outbuildings.

However, there may be some elements which have been constructed and demolished in between the available historic maps, due to changing fashion and styles in country homes.

8.5 The assessment has found a generally low potential for any archaeological activity preceding the medieval and post-medieval period, with any activity of these dates likely to be related to agricultural usage of the land before Henry Flitcroft bought the land for Frognal Grove in the mid-18<sup>th</sup> century. Therefore, any remains of earlier date which has survived the landscaping for Frognal Grove are likely to be agricultural in origins and of limited significance.

## HER Parks

8.6 The proposed development is not anticipated to impact on any of the parks identified in the HER due to the distance and current screening comprising intervening development and treelines between the proposed development and the parks all of which are located *c*.150–170m from the site.

## HER Listed Buildings

8.7 The proposed development is considered to positively impact on the evidential and historic value of the site due to the exposing of historic fabric with the demolition of non-sympathetic elements that are part of the 1960s extension.

## 9.0 Discussion and Conclusions

- 9.1 The archaeological potential for previously unrecorded archaeological remains to be present within the proposed development site is considered low to moderate. However, the proposed scheme of works is considered unlikely to impact on any of the potential remains due to the carefully considered scope of works, which has been designed to avoid impacting on the historic fabric of the building and has utilised existing features within the site to eliminate ground disturbance
- 9.2 Consequently, the development proposals are not anticipated to impact on any *in situ* remains due to the method of construction.
- 9.3 There is considered to be a negligible archaeological potential for prehistoric remains to be present within the search area. While the GLHER has recorded three instances of prehistoric archaeology, no remains are located in proximity to the site and therefore the potential is deemed to be negligible. Equally, the works have been designed as such to remove ground disturbance and thus any archaeological remains will be left untouched.
- 9.4 There is considered to be a low archaeological potential for Roman remains to be present on the site, based on the general lack of intensive Roman archaeology recorded throughout the search area. The presence of two sherds of Roman pottery in proximity to the site has been noted, with this suggesting at least some low-intensity activity of this date within the area but little evidence of substantive settlement.
- 9.5 No early medieval archaeology has been recorded within the search area despite documentary evidence for settlement in Hampstead during the early medieval period. Consequently, it is considered likely that the site has a negligible potential for previously unrecorded early medieval activity.

- 9.6 There is a low to moderate potential for medieval remains to be present within the site, associated with the medieval settlement, as domestic features such as finds scatters, cess pits and structural evidence have been recorded in close proximity to the site although it is more likely that field systems and agricultural activity is present within the site, if it survived the later landscaping. However, the proposed development has been designed to avoid ground disturbance and thus it is not considered likely that there will be any harm to existing archaeological remains, if present within the site.
- 9.7 There is a high potential for post-medieval remains to be present within the site. Postmedieval features associated with the formal gardens shown on 18<sup>th</sup> and 19<sup>th</sup> century mapping may have survived later construction and some buildings associated with the Henry Flitcroft designed site. Any remains could be of some significance, depending on the level of preservation. The works have been planned to use the existing ground contours and shape, thus removing the potential to encounter post-medieval elements of Flitcroft's stables. In addition, the works will not expose any of the 18<sup>th</sup> century building, focussing on areas which were heavily altered during the 1960s renovations and extension of the building.
- 9.8 The assessment has found that the proposed works at 111 Frognal has little anticipated potential to encounter earlier fabric or remains of the Frognal estate, stables, garden or garden structures. The works are within areas of modern construction rather than earlier 18<sup>th</sup> century fabric, with the 1960s work removing the earlier fabric. Consequently, the proposals are not considered to impact on historic environment assets and there are no recommendations for further works.
- 9.9 The final decision on further work rests with the Greater London Archaeological Advisory Service.
