e.g. Oak (T3) - fell because of excessive shading and low amenity value. Replant with one standard ash in same position.

Scarlet Oak T1(tag B5) - declining with upper crown die-back and Honey Fungus invasion to lower main stem - restorative crown reduction overall back to reasonable epicormic growth on main limbs by up to 5 metres to achieve a reduced form for safety reasons and to maintain amenity for the short term.

Holm Oak T2 - raise canopy all around to 4 metres above footpath level

Indian Bean Tree T3 - reduce crown on side facing number 14 Langbourne Avenue by up to 2 metres, raise canopy over footpath to 4 metres and balance whole crown as necessary

Laburnham T4 - Poor condition. Fell and replace

Hawthorn T5 - Poor condition. Fell and replace
