# Certificate of Lawfulness (Proposed) Granted

## Reason for the Decision:

The hip-to-gable and rear roof extensions are permitted under Class B of Part 1 of the Town and Country Planning (General Permitted Development) (England) Order 2015.

The rooflight in the front roofslope is permitted under Class C of Part 1 of the Town and Country Planning (General Permitted Development) (England) Order 2015.

# Informative(s):

- The development would only constitute permitted development if the materials used in any exterior work of the roof extension subject to the grant of this certificate, shall be of similar appearance to those used in the construction of the exterior of the existing dwelling house, in accordance with Condition B.2 of the Town & Country Planning (General Permitted Development) Order 2015.

- The development subject to the grant of this certificate, would only constitute permitted development where the roof lights would project no more than 150 mm beyond the plane of the roof slope in accordance with Condition C.1(b) of the Town & Country Planning (General Permitted Development) Order 2015.
