





EXISTING GROUND FLOOR PLAN




EXISTING SECOND FLOOR PLAN



EXISTING FRONT ELEVATION




EXISTING SOUTH WEST SIDE ELEVATION




### PROPOSED REAR ELEVATION

PROPOSED FRONT ELEVATION






