Erection of replacement single storey rear extension with roof terrace above and replacement of first floor rear door.

The Council has considered your application and decided to grant permission subject to the following condition(s):

Condition(s) and Reason(s):

1 The development hereby permitted must be begun not later than the end of three years from the date of this permission.

Reason: In order to comply with the provisions of Section 91 of the Town and Country Planning Act 1990 (as amended).

All new external work shall be carried out in materials that resemble, as closely as possible, in colour and texture those of the existing building, unless otherwise specified in the approved application.

Reason: To safeguard the appearance of the premises and the character of the immediate area in accordance with the requirements of policy D1 and D2 of the London Borough of Camden Local Plan 2017.

The development hereby permitted shall be carried out in accordance with the following approved plans P020 Rev A, P021, P041 Rev A, P042 & P043

Reason: For the avoidance of doubt and in the interest of proper planning.

Informative(s):

1 Reasons for granting permission.

The proposed replacement single storey rear extension is considered acceptable in terms of design. It would be of a similar size and siting as the existing, retaining the existing masonry wall to the south and using appropriate materials for the remainder of the extension. The new replacement extension would incorporate rear sliding glazed doors as opposed to a concertina style and the roof terrace above would be surrounded by more traditional black metal railings as opposed to a contemporary glass balustrade. The proposal would also involve altering the first floor rear access door and window into a timber French doors of a similar style, fitting a similar opening size. As such, it is not considered there would be any significant detrimental harm to the character and appearance of the subject property or wider conservation area.

It is not considered that there would be any significant detrimental impact to residential amenity. In terms of light and outlook, the proposed alterations would involve no notable increase in bulk and mass to the subject property and would cause no further harm. In terms of overlooking and privacy, the roof terrace and rear extension would afford no new views beyond what has been established by the existing.

No objections were received following statutory consultation. The sites planning history and relevant appeal decisions were taken into account when coming to this decision.

Special regard has been attached to the desirability of preserving or enhancing the conservation area, under s.72 of the Planning (Listed Buildings and Conservation Areas) Act 1990 as amended by the Enterprise and Regulatory Reform Act 2013.

As such, the proposal is in general accordance with Policies D1, D2 and A1 of the Camden Local Plan 2017. The proposed development also accords with the policies of the London Plan 2016 and National Planning Policy Framework.
