5.1 CLEANING:

The stonework and terrazzo will be cleaned by hand with a TFR cleaner. This is an alkaline based product which will be mixed between 5 and 1 and 10 and 1 with water depending on the staining.

Firstly the floors will be swept to remove any dust, the detergent will then be generously applied to the surface and left for a while to penetrate the surface. Once the detergent has had a chance to soak in, the walls and floors will be mechanically scrubbed using a geared spinner and floor cleaning pad. Once all areas have been cleaned, all water will be picked up with a wet vac and a final clean with clean water and a mop.

6.0 NECESSARY PROTECTION:

All operatives will wear gloves and glasses whilst carrying out the cleaning.

Caution cleaning signs will be placed around the working areas with caution wet floors placed out when we have moved away from each area.

7.0 ACCESS:

All areas are accessible from the ground.

8.0 OTHER TRADES:

Any other trades should be made aware of our works when on site. There may be some dripping water, but nothing that is dangerous

10.0 First Aid

First Aid kits to be kept the site office, First aiders are to be introduced upon the site induction

11.0 Storage

Materials not being used immediately shall be stored in a locked container supplied by the site.

12.0 PPE

The Personal Protective Equipment (PPE) provided is supplied for your own (Personal Protective Equipment) protection. These items must be worn at all times. If any of the items bellow get lost or damaged you must report it to Barwin office immediately.
