For the avoidance of doubt and in the interest of proper planning.

## Informative(s):

1 Reasons for granting permission:

The application site contains a three-storey terraced building within the Mansfield Conservation area but is not listed. The proposal includes the removal and replacement of windows and doors at the rear elevation.

The proposed windows and doors will have the same size of opening as the existing but the colour of the frame is changed from green to bronze. The style of the windows will also be different and the material of the windows and doors will change from timber to Aluminium. The existing fenestration are not original and the windows and doors in question are at the rear of the property which would not be visible in the public realm. They are visible from private vantage points, yet due to their detailed design, they would not adversely impact the character and appearance of the hosting building and wider Conservation Area.

The proposed development would not result in additional overlooking of neighbouring residential properties or cause other harmful amenity impacts.

No objections have been received prior to making this decision. The site's planning history and relevant appeal decisions were taken into account when coming to this decision.

Special regard has been attached to the desirability of preserving or enhancing the conservation area, under s.72 of the Planning (Listed Buildings and Conservation Areas) Act 1990 as amended by the Enterprise and Regulatory Reform Act 2013.

As such, the proposed development is in general accordance with policies A1, D1 and D2 of the Camden Local Plan 2017 and policies DH1 and DH2 of the Hampstead Neighbourhood Plan 2018. The proposed development also accords with the London Plan 2016 and the NPPF 2019.
