Sycamore (T2) - Removal of a middle-aged tree in poor condition.

Reason - Due to its poor condition it shows that this is not the best place for healthy growth; it is causing damage to the boundary wall and the adjacent footpath; the relatively young tree is dominated by the presence of larger better-quality trees in the immediate vicinity.

As per the condition of the planning permission of the developments the removed tree will be replaced as soon as is reasonably possible and, in any case, by not later than the end of the following planting season, with others of similar size and species.
