Replacing sounds very nice but look what grows in the spot of the one Leiland Cypress that was chopped down two years ago ¿ nothing. 				The 4x trees continue to grow in height by aprox 1M per annum accompanied by increased spread. The height now exceeds that of the close mansion block.			
				The east most tree (standing alone) seems particularly vulnerable in high winds. It can be seen swing alarmingly in high winds and it is my opinion there is genuine risk to (at least) this tree falling on cars, to or people. Please be aware that Leyland Cypress have a shallow root system without the deep "tap roassociated with many trees which acts as an anchor. The root system is further compromised by the st land aspect and cloe by path and road.  I would strongly recommend at least the east most tree be felled and a replacements sought. Moving as the new trees mature, the other three Leyland Cypress might be replaced. Apart from for safety reacreful planting of new trees will greatly enhance the conservation area.			
				If a decision to remove one or all the four trees is taken, I suggest a ground specialist is sought any subsidence/heave impact on the adjacent road in particular as the roots gradually rot away extraction rates are altered.
