Proposal:

Replacement of the lath and plaster ceiling under the gallery, as well as structural alterations (strengthening works).

Drawing Nos: Site Location Plan; 1251-101; 1810-102 Rev. A; Method Statement; Visual Inspection Report.

The Council has considered your application and decided to grant Listed Building Consent subject to the following condition(s):

Conditions And Reasons:

- 1 The works hereby permitted shall be begun not later than the end of three years from the date of this consent.
 - Reason: In order to comply with the provisions of Section 18 of the Planning (Listed Buildings and Conservation Areas) Act 1990.
- 2 The development hereby permitted shall be carried out in accordance with the following approved plans: Site Location Plan; 1251-101; 1810-102 Rev. A; Method Statement; Visual Inspection Report.

Reason: In order to safeguard the special architectural and historic interest of the building in accordance with the requirements of policy D2 of the Camden Local Plan 2017.

3 All new work and work of making good shall be carried out to match the existing adjacent work as closely as possible in materials and detailed execution.

Informative(s):

1 The application seeks consent for the replacement of the lath and plaster ceiling under the gallery, as well as structural alterations.

The Church of St John is a Grade I listed building dating from 1818-23. The proposal relates to the south-west gallery lath and plaster ceiling. This ceiling was removed without the necessary permission. The application proposes to replace the ceiling with woodwool boards with a lime plaster finish. Whilst it is acknowledged the potential benefits of using a lighter material, the gallery itself is structurally sound and has had a lath and plaster ceiling in situ for the last two hundred years. This is a highly significant building, and a traditional lath and plaster ceiling is considered to be the appropriate repair. The application has been amended to reflect this.

The application also proposes timber support strengthening to historic structural elements. The approach to repair is considered to preserve the special interest of the listed building.

Public consultation was undertaken for this application by means of a press notice and a site notice. Two responses were received. Historic England responded on 17/12/2019 and advised that the ceiling should be reinstated in traditional lath and plaster (not the lime plaster on woodwool slabs). The Georgian Group responded on 18/12/2019 stating that "We do not believe that the introduction of backing board with uncertain longevity to be an appropriate material in a Grade I building. It is extremely regrettable that the original ceiling was removed, and under the circumstances we believe that a like-for-like replacement be the recommended course of action".

The site's planning history was taken into account when arriving at this decision.

Special regard has been attached to the desirability of preserving the listed building and its features of special architectural or historic interest, under s.16 of the Planning (Listed Buildings and Conservation Areas) Act 1990 as amended by the Enterprise and Regulatory Reform Act (ERR) 2013.

As such, the proposal is in general accordance with policies D1 and D2 of the

- Camden Local Plan 2017. The proposed development also accords with the London Plan 2016 and the National Planning Policy Framework.
- Your proposals may be subject to control under the Building Regulations and/or the London Buildings Acts that cover aspects including fire and emergency escape, access and facilities for people with disabilities and sound insulation between dwellings.
