Sorbus (T2) – Reduce/remove the branches overhanging the garden.

Copper beech (T3) – Remove the branches over the garden. Reduce the whole crown by 1.5m on all aspects.

Fig (rear) (T4) – Reduce crown by 3m on all aspects. Remove the lower stem.

Cherry (T5) – Thin crown by removing rubbing and crossing branches.
The trees are close to the house and need regular pruning.
