

This document has been prepared to address the provisions of the Hawley Wharf planning permission (LPA Ref: 2018/1715/P, dated 3 December 2018) as set out below.

## Planning condition 10:

The details of the cinema to include Art House occupant, capacity of visitors, number of screens, associated food and drink uses, and accessibility shall first be submitted to and approved in writing by the Council prior to occupation of this part of the development ('Area C'). The cinema shall not operate otherwise than in accordance with the details thus approved.

Reason: To safeguard the amenities of the adjoining premises and the area generally in accordance with the requirements of policies A1 and A4 of the London Borough of Camden Local Plan 2017.

## Planning Obligation:

"Cinema Plan" means a plan identifying possible measures to be implemented by the cinema operator to encourage cultural and educational outreach programmes for local residents and children and ensuring compliance with the Council licensing requirements.

Schedule 1 Part 3 Clause 1: "Prior to Occupation of Area C, the Owner shall submit to the Council for approval the Cinema Plan.""

**Operating name:** Curzon Camden (subject to change)
