I am the Camden Councillor for the Kentish Town ward in which these premises are located. I am writing to endorse the objection of Kentish Town Road Action (KTRA) to the element in this Planning application that deals with the proposed Hours of Opening on Saturdays. I quote their objection below:

'We understand that Planning officers do not usually concern themselves with Licensing matters, but in this case Planning and Licensing are interlinked, and some background needs to be known.

The Hours applied for on Saturday are 11.00 – 02.00.

These very late hours are unsuitable for this area of Kentish Town. 'The Forum' venue, at 9-17 Highgate

Road, is only seven buildings away from 385 Kentish Town Road. Hundreds of customers stream past

no.385 on their way to and from 'The Forum' to attend its many gigs. If these premises remain open until

02.00 on Saturday, for whatever purpose, customers and passing trade will be hanging around in the street

until the early hours, waiting for taxis or late night public transport.

Numbers 1-5 Highgate Road, five buildings away from 385 Kentish Town Road, are tall multi-occupied

residential buildings. There are residential flats above all the shops on the street, and in the buildings

opposite. Residents in all these flats and houses will find their sleep disturbed by the noise of customers

leaving the restaurant early in the morning. Customers will hang around the street waiting for early morning

transport and taxis.

Until this Premises Licence was applied for the premises held an historic Late Night Refreshment licence

from 23.00-03.00 on Saturday. It is clear that the owner of these premises intends to apply for another late

night refreshment licence, and probably an alcohol licence, once he has the Premises licence. He applied

for very late refreshment and alcohol licences recently but was instructed by Camden to apply for a

Premises licence first.

KTRA is asking for an amendment to the Saturday Opening Hours applied for. The end hour applied for on

Saturday is two hours past the Licensing Framework Hour, which is midnight. We are asking for an

amendment to the Planning application – reducing the Saturday Opening Hours from 02.00 to 24.30 for the

reasons given above. '

As the Kentish Town ward Councillor, I am able to verify the grounds for these objections. My Surgeries

are frequently attended by residents whose lives are made a misery by disturbances caused by breaches

of Camden's Licensing Framework Hours.
