GRANT CONSENT FOR WORKS TO TREE/S UNDER A TREE PRESERVATION

Proposal:

ON COMMUNAL GROUND: 1 x Robinia Pseudoacacia (T1) - Removal of lowest SE facing limb back to main stem.

- 1 x Holly (T3) Reduce down to 1 foot above previous reduction points, approx. 30% reduction.
- 1 x Pin Oak (T4) Thin by 5% all round.
- 1 x Ash (T6) Prune back NE side to give a maximum 3 feet clearance from Bay tree and removal of approx. 5% of epicormic growth.
- 1 x Oak (T7) Prune all around by 0.5 1m, including removal of 5% of epicormic growth below crown break.

The Council has considered your application dated 19 September 2019 and decided to grant consent subject to the following condition(s):

Conditions and Reasons:

This decision is valid for 2 years from the date of this decision or until the work is completed, which ever is the sooner.



Reason: To allow the Local planning authority to monitor the completion and standards of the work.

All work shall be carried out in accordance with the relevant recommendations of British Standard 3998: 2010. (Recommendation for Tree Work)

Reason: To ensure the preservation of the amenity value and health of the tree(s).
