## Rossmoregate group of companies ("Rossmoregate Group")

We understand our mutual client, the Rossmoregate Group, are appealing against the initial rejection of Planning Application 2017/7051/P on the potential mixed change of use with extension of 135-149 Shaftesbury Avenue, London, WC2H 8AH.

RSM UK Audit LLP and its predecessor firms have acted as auditor to the Rossmoregate Group for the last ten years. The principal activity of the Rossmoregate Group is that of property dealing, property investment and the operation of restaurants, a hotel and spa.
