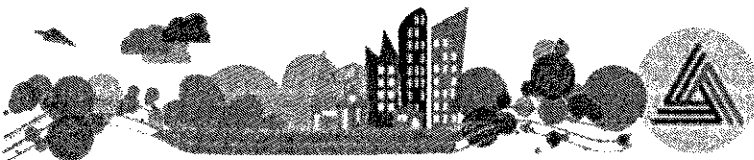

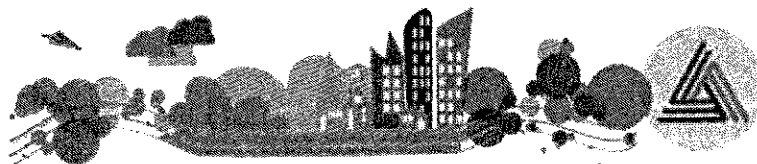

Thanks for your time on the phone last evening.

We discussed officers' views on Dr Phillips' report and you noted that following discussions with Bethany Cullen and Neil McDonald officers are of the view that the report does not explicitly address the three key questions within the brief. You have since replied to Duncan Phillips (your email below) asking him to amend his report to answer each question.

As mentioned, our view is that the report answers these questions in line with the brief. This is evidenced by Dr Phillips confirming that he agrees with the findings contained within the professional reports he was asked to review. If he did not agree with these conclusions, then this would have been made clear in his report. It is also worth noting that Dr Phillips in his email to you when he issued his report, mentioned that this scheme is very straightforward from his point of view in terms of heritage.

To give officers the clarity that you need, we suggest that Dr Phillips update his report with additional clarifications that specifically address the three questions. This should be able to be completed quickly and easily. For example, explicit clarification could be provided by:

- Listing the defects identified by Hallas and Co in their building condition report and confirming that he agrees with these.
- Confirming that he agrees with the repair, maintenance and refurbishment works needed to rectify the defects identified by Hallas and Co.
- Confirming that he agrees with the £10million cost estimate identified by Hallas and Co required to carry out the above works.

This would address the first two questions in relation to proposed works and costs and align with what Dr Phillips has already said in his report.

In terms of the third point, we would suggest that he includes a paragraph or two following his assessment of significance. As Dr Phillips has concluded that he finds no significance internally and that he agrees with the viability of the proposed works and the associated costs (which have also been independently verified by BPS), perhaps the best way to explicitly answer this question could be through a sentence similar to the following:

- My findings within this review demonstrate that a considerable programme of works is required to be undertaken in order for the building to be viably redeveloped, and that the proposed scheme does not cause undue or unacceptable harm to the significance of the listed building. As such, it is clear that a reduced scope of work, such as the work identified in the Hallas and Co report, would be insufficient to secure the future of the building, and would also not generate fewer conflicts with the building's significance.

As mentioned earlier, we are of the view that all of these questions have been answered indirectly by Dr Phillips in his original report. We believe that simple clarifying sentences or statements similar to what we have set out above will give officers the comfort you need on this matter. This should be able to be resolved quickly to allow the scheme to be presented at the 18 October Planning Committee.

We hope you find this helpful and we would be grateful if you could pass these suggestions onto Dr Phillips when you speak with him today. Please could you copy us in on any correspondence.

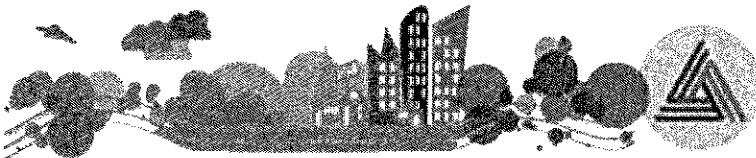

Thank you for your review Duncan,

The HR and its objectives were as follows:

With reference to relevant national policy and guidance, including Planning Practice Guidance section 18a and Historic England's Good Practice Advice (HE GPA) Note 2, and an understanding of the building's significance, produce a Report summarising your expert view on:

- *Proposed works: To help verify the conservation deficit, distinguish among the proposed works those which are necessary for repair, maintenance and reasonable refurbishment of the building, and based on inspection of the building identify other remedial works necessary.*
- *Costs: Given your understanding of the building's condition, do the costings appear appropriate?*
- *Justification: Noting particularly the need to avoid, minimise and mitigate harm, identify any conflicts with conservation of the building's existing significance among the proposed works. Based on your understanding of the building's present condition and the costs and feasibility of intervention, do you judge a scheme which could avoid these conflicts and/or enhance significance likely to be viable? (PPG sec. 18a paras. 15 & 19; HE GPA 2 para. 26)*

Having had time to review your submission, I can only find a substantial view on significance, which was not one of our three key questions. I would therefore ask you to address these key questions and provide a timeline for its completion.

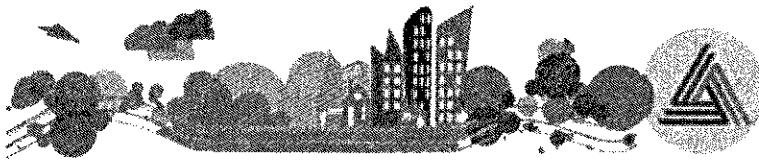

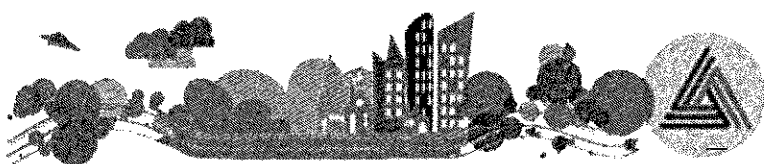

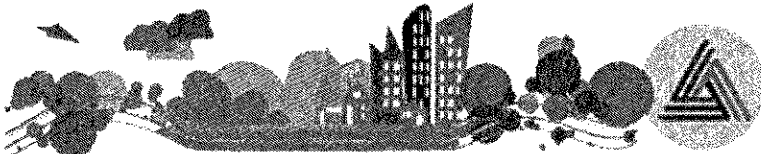
