- Proposals for planting replacement trees (including quantity, species, position and size) or reasons for not wanting to replant.

e.g. Oak (T3) - fell because of excessive shading and low amenity value. Replant with one standard ash in same position.

FRONT garden GRP4 = Small self-set ASH Saplings – Fell as close as possible to ground level and apply herbicide to stumps.

REAR garden with side access GRP1 = Large mixed PRIVET + other Vegetation (originating from No.18) – Face back to boundary line.

GRP2 & GRP3 = Medium IVY + mixed Vegetation - Face back to boundary line and tidy up.

T1 = Medium ASH - Lightly retrim and reshape as per previous practise.

T2 = Medium HOLLY - Lightly retrim and reshape as per previous practise.

T3 = Medium BAY - Lightly retrim and reshape as per previous practise.

T4 = Large CONIFER –

Remove co-dominate stem that leans across rear boundary wall ONLY.
