In regard to the members briefing panel meeting for the above application I hope that you are able to express to the panel how much time and effort has been taken by the local community to ensure that no unnecessary or damaging building works take place at number 26 Netherhall Gardens and that you are able to recommend that any decisions on this application go to the full planning committee. We feel very strongly about this site and wish to preserve its situation in terms of amenity and overall structure as befits a building in the Netherhall Conservation area. I would also like the panel to consider the following important points about the boundary trees.

I am very concerned about the false information presented in the planning application about the position of trees at the boundary of 24A and 26 Netherhall. Due to the proximity of the proposed building to the boundary of 24A it is obvious that the proposed works will impact badly on the trees, one of which has an extensive canopy and is therefore at maximum efficiency for carbon capture. I sincerely hope that you will ensure that these trees are conserved at a time when government policy is to plant more trees as part of the critical effort towards protecting our climate and environment.
