The guidance also provides guidance on the specification of bulk waste storage areas,

- well-lit and ventilated; 2 windows (fixed shut), extract ventilation to central disposal
- 0.0 close to any on-site incineration or other disposal facility;
- used by the public; v sited away from food preparation and general storage areas, and from routes
- totally enclosed and secure; v
- .→ o provided with separate storage for sharps receptacles, anatomical and waste medicines, which may need a higher degree of security to prevent unauthorised Access control?
- sited on a well-drained, impervious hardstanding;
- ÞΘ readily accessible but only to authorised people; Access control?
- kept locked when not in use;
- secure from entry by animals and free from insect or rodent infestations;
- provided with wash-down facilities; Not provided
- provided with washing facilities for employees; Net provide
- 3 clearly marked with warning signs;
- provided with separate, clearly-labelled areas for waste that requires, rather than is destined for, different treatment/disposal options;
- provided with access to first-aid facilities; Not clear if this has been provided
- appropriately drained to a sewer (with discharge consent).

"All bulk stores should have storage capacity to match the proposed frequency of collection. Bank (or other) holidays need to be taken into account and a margin provided for any interruption in the disposal system."

The above summary from HTM07-01 brings together the requirements of several pieces of legislation and is regulated by the Health and Safety Executive, Department for Transport and the Environment Agency.
