It is proposed to carry out minor alterations to the plan to the rear rooms on second and third floor, resulting in no loss of historic fabric. It is proposed to refurbish the building throughout, including kitchens and bathrooms. It is proposed to re-introduce timber wall panelling throughout. It is proposed to extend the existing staircase up a further flight to give access to the roof terrace, following the existing plan but in a lightweight material so as to be easily discernible from the existing staircase. It is proposed to replace the modern roof light with an openable roof light to replace the existing lean-to light and cabin. It is proposed to bring back the line of the railing at roof level to not be visible from the street .

Lean to roof light presumed to be constructed in 1982 (date of permission granted) along with cabin giving access to the roof by way of a ladder from third floor landing, presumed to be constructed at the same time.

Why is it necessary to demolish or extend (as applicable) all or part of the building(s) and or structure(s)?

The historic fabric of the roof was lost when the current roof light was installed in 1982. The provision of a larger roof light in place of the existing roof light and staircase enclosure would not result in any significant loss of historic fabric as the roof structure appears to be entirely modern. In addition the new rooflight will allow for a cleaner roof line and would remove roof level clutter.
