The works we are applying for are:

T1 Strawberry Tree Fell and treat stump to inhibit regrowth.

The reasons for the application are as follows:

•No 11 has been subject to a form of cracking indicative of downward movement of foundations. That this movement was predominantly focused to the front bay area.

•Engineers are of the opinion movement of the building is consistent with that induced by tree induced moisture abstraction of an underlying clay soil. •That the removal of the Sorbus spp (ST1) within the public highway footpath did not stop damage.

•That level monitoring shows clear downward movement of the property between March 2018 and May 2018 when the only remaining tree able to influence No 11 is T1

An application to remove is being made as the tree is too large and too close for pruning to offer an effective remedy.

•That there is sufficient information for the local authority to determine this TPO application as level monitoring information shows the remaining influencing factor on the property is T1 •That in the event of a refusal the property will be underpinned. Section 202E of The Act allows compensation to be sought for additional costs incurred as a

result of such a refusal.

•That allowing for the underpinning works and legal fees to bring such a claim the additional cost would be not <£60,000 •That in granting permission for the removal of T1 the council would remove their exposure to this compensation claim cost.
