Suggested works:

- Reduce crown all round back to previous reduction points approx. 2-3m
- Remove epicormic growth
- Clean out crown

Front garden

T4 Lawsons Cypress x 1 (Chamaecyparis lawsoniana) Suggested works:

- Reduce all round by 1-2m retaining greenery and shape
- Lift my 2m over shrubs

Side of property

T5 London Plane x 1 (Platanus x hispanica) Very large mature tree over hanging green house and swimming pool.

Suggested works:

- Reduce the crown all round by 2m using advanced rigging techniques
- Reduce overlong into the new main crown

Front of no 59 Maresfield Gardens

T6 Lime x 1 (Tilia spp) Large previously reduced tree.

Suggested works:

- Reduce back to previous reduction points 2m
- Remove epicormic growth

Rear garden

T7 Cypress x 2 Suggested works:

- Reduce over long branches over the garden into the main crown

Rear garden

T8 Lime x 1 (Tilia spp) Large mature previously reduced tree.

Suggested works:

- Reduce crown all round back to previous reduction points approx. 2-3m
- Remove epicormic growth
