e.g. Oak (T3) - fell because of excessive shading and low amenity value. Replant with one standard ash in same position.

Hornbeam

Option 1:

Fell because tree now obstructs and restricts access to the property (basement). The trunk is growing over the paving stones and the access width to the basement flat is now less than 2 feet. This is an impractical width for access. In addition, an unobstructed access width of 3 feet is considered the minimum for access by emergency services such as fire and ambulance. Replant with one standard Hornbeam (or alternative species and size as advised by Camden Tree Team) in the centre of the front garden (approximately 1.5 m from current position).

Option 2:

Reduce by 30% approximately 1.5-2.0 m. This does not solve the access problem.
