Although most local people do not use it regularly, a significant albeit minority number of local people rely on it for all their needs. Many more rely on it as a back up in case of failure of their own washing machine. The application claims, incorrectly, that one can have clothes cleaned in the dry cleaners shop next door but in fact that dry cleaners does not provide a comparable service to the launderette regarding self service clothes washing in water nor serviced washing in water of everyday clothes. Some local people rely on the launderette for their clothes washing because they do not have access to a washing machine at their home and in many cases do not have space to install one or are tenants and not allowed by landlord or able to install one. The launderette is their only option. Some local people including me rely on the Launderette as a back up, for use when our home facilities are not working or overloaded. The applicant claims the local plan stipulated 50% of local shop units need to be retail and a change of use to A1 will some how increase the retail use in the road but that is a false claim because launderette is a retail use and a very valuable retail use for the many local people who rely on it. It would be very difficult for a new launderette in a different shop to get planning consent for Launderette because there are numerous special needs that such use would require to be in place and they are likely cost prohibitive for a new operation. Hence if the shop at 47 Englands lane were to be permitted to be operated as other than Launderette it would likely mean the local area will never get a replacement. In other words if this launderette changes to A 1or 2 or 3 or 4 or 5 use it will result in the local area never having a launderette again. The absence of a launderette in other parts of Camden mean that it is used by people beyond its immediate area and so serves a wider community than just its very loca

I feel that the presence of a launderette is essential in every locality as a social amenity, especially where there are many flats and places of multiple occupancy, including social housing, hostels et cetera. Many people do not have access to their own washing machine either because they do not have one or because they share with other people, limiting access clothes washing facilities. Anyone might need the services of a launderette to wash large items, such as duvets, (too large for domestic washing machines) which can be important in maintaining cleanliness and therefore good health. There is also the case where somebody finds themselves temporarily without a washing machine due to a technical break down. Everybody needs the right to keep themselves and their clothes clean, it's essential for well-being and employability. It's a matter of social equality ¿ no one should be denied access to cleanliness because of means. As I understand it, this launderette is used regularly, so it is obviously of use in the community. If it did not exist, it would be necessary to travel some distance to find an alternative.
