- Clean to remove all dead, diseased and broken branches 2 centimetres in diameter and larger throughout crown to improve health and appearance and reduce risk of branch failure.

Prune T2 Oak located at the back of property according to the following specifications:

- Reduce crown height by approximately 4-5 metres to reduce risk of branch, stem and/or root failure.

Prune T3 Horse chestnut located at the Neighbouring Left Garden according to the following specifications:

- Lateral branch growing into trees a rear of property remove back to boundary fence line

Prune T4 Laurel located at the right side rear garden according to the following specifications:

- Reduce crown spread by approximately 0.5-1 metre to renovate overgrown shrubs.
- Trim to maintain appearance of hedge
