T1 - Robinia - Reduce crown by 2m from the extent of each branch, leaving intact furnishing growth for improved crown continuity where possible, although it appears the tree was first pollarded about 20 years ago and has been reduced several times. Tree dimensions to change from 12m tall x 8m wide, to £10m tall x 5m wide. Maintenance due to no space for future growth.
