- Reduce in height by approx. 4meters
- Round off tops to give a natural appearance
- Trim in sides to shape and contain

T1. Bay. A nice tree sighted in a good location in the garden. In order to contain the growth and size of the tree suggested works are to:

- Reduce growth back to previous points of reduction
- Trim hard all round to shape and contain.
