-reduce height of both trees by 30% (2m) to suitable growth points
-cut back front face and sides of both trees by 1m to shape and tidy

(T2) - Cherry (Prunus) - poss. diseased/stressed w/evidence of fungal disease (Kreuztmaria)
- light redirects by 20% to thin shape and tidy

(T3) - Fig (Ficus carica)
-reduce by 20% reducing new growth by 0.6m to suitable growth points
