Sycamore (T1) – Fell dead tree. It's dead and needs to be removed!

Sycamore (T2) – Reduce crown back to previous most recent cuts. This is to allow more light into the property, restrict root growth and open up the front garden a bit more.

Holly (T3) - Prune back to the edge of the paving slabs. To allow more light into the house and increase visibility.

Yew (T4) - Prune back to the hedge of the paving slabs. To allow more light into the house and increase visibility.
