**PROPOSED BASE STATION INSTALLATION AT CELL SITE REF 150406, SOUTHFLEET, MALDEN ROAD, BELSIZE PARK, CAMDEN, GREATER LONDON, NW5 4DH**

This submission is a full planning application and is in accordance with the Electronic Communications Code (as amended) for permission for the development of:

*Removal of 6No. antennas & installation of 12No. upgraded antennas, 2No. 600mm dishes, 1No. 300mm dish & 6No. equipment cabinets at rooftop, all housed within GRP screening to match existing building materials, plus ancillary works at Southfleet, Malden Road, Belsize Park, Camden, Greater London, NW5 4DH, NGR: E 528196, N 184849*

Telefónica UK Limited has entered into an agreement with Vodafone Limited pursuant to which the two companies plan to jointly operate and manage a single network grid across the UK. These arrangements will be overseen by Cornerstone Telecommunications Infrastructure Ltd (Cornerstone) which is a joint venture company owned by Telefónica UK Limited and Vodafone Limited.

This agreement allows both organisations to:

- pool their basic network infrastructure, while running two, independent, nationwide networks
- maximise opportunities to consolidate the number of base stations
- significantly reduce the environmental impact of network development
