Condition 4 (Ref:2019/1693/L) requires: Detailed drawings, or samples of

materials as appropriate, in respect of the following, shall be submitted to and approved in writing by the local planning authority before the relevant part of the work is begun:

a) Typical details of new stone name plaques at a scale of 1:5 and to include sections at 1:1 showing font details, stone identification/comparison, finish and method of fixing into the existing Portland stone.

The submitted details are considered sufficient to discharge Condition 4) Details of Stone plaques and fixings.

Public consultation was carried out through a press notice and a site notice. No responses were received.

The site's planning history has been taken into account when making this decision

Special regard has been attached to the desirability of preserving the listed building and its features of special architectural or historic interest, under s.16 of the Planning (Listed Buildings and Conservation Areas) Act 1990 as amended by the Enterprise and Regulatory Reform Act (ERR) 2013.

As such, the proposal is in general accordance with policies D1 and D2 of the Camden Local Plan 2017. The proposed development also accords with the London Plan 2016 and the National Planning Policy Framework.
