Two London plane trees in the rear of 147-149 St Pancras Way:

Works to demolish and install a new retaining wall at the rear of 12 Rousden Tree are required as the existing wall is now cracking and liable to failure. The attached Arboricultural Method Statement and Tree Protection Plan as been prepared for the contractors and describes the methodology, however we are advised by Nick Bell, Tree Officer, that a tree works application is also required for should any part of the tree need pruning during demolition and construction.

Therefore this application is for the pruning (if necessary) of individual roots and clumps of roots less than 25mm width. They will be cut cleanly and pruned back to a distance of 100–200mm behind the final face of the excavation. Individual roots and clumps of roots over 25mm will only be cut if agreed by the supervising arboriculturist. this is detailed within the attached method statement.
