Proposal:

WEST SIDE OF GARDENS: 1 x London Plane (Platanus x hispanica) (T80) - Remove faulted limb / limbs - significantly decayed limb from approx. 8 - 9m to the north over shrub bed and footpath - remove damaged section to at least historic pruning wound at knuckle (more if required).

EAST SIDE OF GARDENS: 1 x London Plane (Platanus x hispanica) (T91): RVL - Remove faulted limb / limbs - damaged branch at approx. 18m north east over highway.

The Council has considered your application dated 14 February 2020 and decided to grant consent subject to the following condition(s):

Conditions and Reasons:

- 1 This decision is valid for 2 years from the date of this decision or until the work is completed, whichever is the sooner.

Reason: To allow the Local planning authority to monitor the completion and standards of the work.

- 2 All work shall be carried out in accordance with the relevant recommendations of

British Standard 3998: 2010. (Recommendation for Tree Work)

Reason: To ensure the preservation of the amenity value and health of the tree(s).
