1 Reason for granting permission

Revised details have been provided that include a detailed maintenance plan and details of the planting species and density. A Bauder mat/blanket system is proposed (product Wildflower Blanket Xero Flor XF118). It would comprise of 24 native species. The roof would be maintained in accordance with Bauder's maintenance information. Nature conservation officers have reviewed the submitted details and confirmed the submitted details are satisfactory in demonstrating that the development would undertake reasonable measures to

take account of biodiversity at the site.
