Noise from demolition and construction works is subject to control under the Control of Pollution Act 1974. You must carry out any building works that can be heard at the boundary of the site only between 08.00 and 18.00 hours Monday to Friday and 08.00 to 13.00 on Saturday and not at all on Sundays and Public Holidays. You must secure the approval of the Council's Noise and Licensing Enforcement Team prior to undertaking such activities outside these hours.

- 5 Reason for granting listed building consent: The host building is a Grade II* listed late 19th/early 20th Century polished granite, red brick and red terracotta office by Alfred Waterhouse in the picturesque Gothic Revival style. Parts of the building were added in 1930-32 by EM Joseph with rebuilding taking place in 1989-93. The building is located in a prominent location within the Hatton Garden Conservation Area.

This Conservation Area covers approximately 20 hectares West of Farringdon Road. Its historic character derives largely from its many robustly detailed industrial, commercial and residential buildings of the late nineteenth to mid twentieth centuries, combined with an intricate street pattern that is overlaid on undulating topography. Parts of the building were altered to accommodate communal office work space in 2018 (under application ref 2018/3457/L). The application seeks to carry out further fit out works to the first floor and seventh floor of the Grade II* listed building. These works are minimal and do not affect historic fabric or the legibility of the historic plan form.

For the reasons set out above, it is considered that the proposed works will not harm the special interest of the Grade II* listed building.

The application has been advertised in the press and by means of a site notice, whereby there were no consultation responses. Historic England have responded to state that the local authority should determine the application as they see fit and their correspondence has been stamped by the NPCU. The site's planning history has been taken into account in making this decision.

Special attention has been paid to the desirability of preserving the special interest of the listed building, under s.16 of the Listed Buildings and Conservation Areas Act 1990 as amended by the Enterprise and Regulatory Reform Act (ERR) 2013

As such, the proposal is in accordance with Policies D1 and D2 of the Camden Local Plan 2017. The proposed development also accords with the London Plan 2016 and the NPPF.

In dealing with the application, the Council has sought to work with the applicant in a positive and proactive way in accordance with paragraph 38 of the National Planning Policy Framework 2019.
