Replacement of the existing doors on Tavistock Place frontage by new doors and formation of a new access ramp and associated railings to create new main entrance on front elevation

The Council has considered your application and decided to grant permission subject to the following condition(s):

#### Condition(s) and Reason(s):

1 The development hereby permitted must be begun not later than the end of three years from the date of this permission.

Reason: In order to comply with the provisions of Section 91 of the Town and Country Planning Act 1990 (as amended).

2 All new external work shall be carried out in materials that resemble, as closely

as possible, in colour and texture those of the existing building, unless otherwise specified in the approved application.

Reason: To safeguard the appearance of the premises and the character of the immediate area in accordance with the requirements of policies D1 and D2 of the London Borough of Camden Local Plan 2017.

The development hereby permitted shall be carried out in accordance with the following approved plans- Design and Access Statement revision P02 dated 28.11.19 by BMJ Architects; Planning and Heritage Statement dated 12.12.19 by Montagu Evans; PL(00) 03B, 70A, 71A, 80, 90, 91, 92, 93, 99

Reason: For the avoidance of doubt and in the interest of proper planning.

- 2 Reasons for granting permission.

The scheme aims to provide a new replacement main entrance to the School in a more welcoming and prominent position on the Tavistock Place frontage. The new replacement glazed timber doors reflect the design and materials of existing doors along this façade and are a welcome improvement over the existing poor quality timber doors here. The new short entrance ramp is required for accessibility reasons and is located on the front forecourt adjacent to the front lightwell, so will not create an obstruction to pedestrian movement along Tavistock Place. The associated railings match the height and detailed design of adjoining railings around the lightwell. Overall the design, form and location of the alterations are acceptable and will not harm the character and appearance of the building, streetscene or conservation area.

Special attention has been paid to the desirability of preserving or enhancing the character or appearance of the Conservation Area, under s.72 of the Planning (Listed Buildings and Conservation Areas) Act 1990 as amended by the Enterprise and Regulatory Reform Act 2013.

The proposal is not considered to cause any adverse impacts on the amenity of adjoining residential occupiers.

No objections have been received prior to making this decision. The planning history of the site has been taken into account when coming to this decision.

As such, the proposed development is in general accordance with policies A1, C6, D1 and D2 of the Camden Local Plan 2017. The proposed development also accords with the London Plan 2016 and the National Planning Policy

Framework 2019.

- This approval does not authorise the use of the public highway.
