e.g. Oak (T3) - fell because of excessive shading and low amenity value. Replant with one standard ash in same position.

To fell three Lime trees (G1) in the rear garden of Prince Arthur Road.

- The trees are pushing over the wall between No.14 Prince Arthur Road and No.110 Fitzjohn's Avenue.
- The trees drop sticky honeydew onto the garden below.
- The epicormic growth that forms on the stem and bases of the trees is considered unsightly.
- The trees are lapsed pollards that have been managed by crown reductions and so need regular and expensive pruning to maintain them in a safe manner.

Mitigation planting:

It is proposed to plant six (better suited) new trees in the rear garden – a Liquidambar styraciflua; a Koelreuteria paniculata, a tree-form of Osmanthus heterophyllus and three Cornus kousa 'chinensis'.
