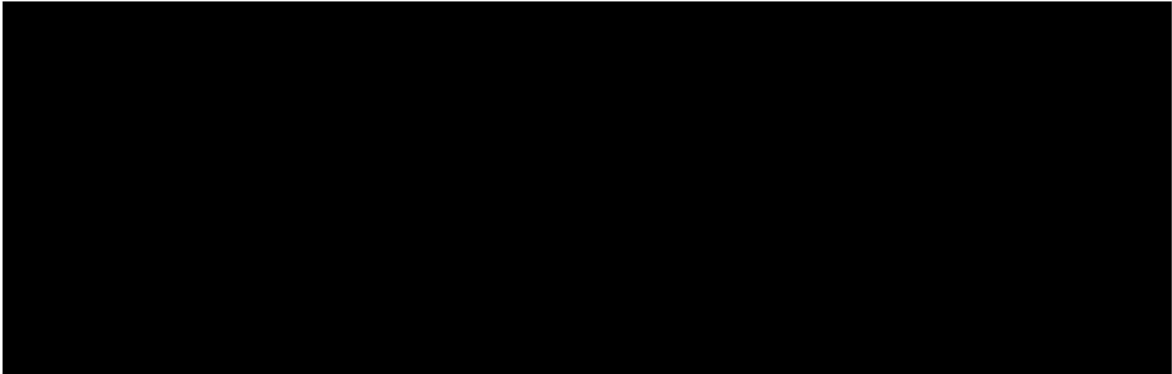
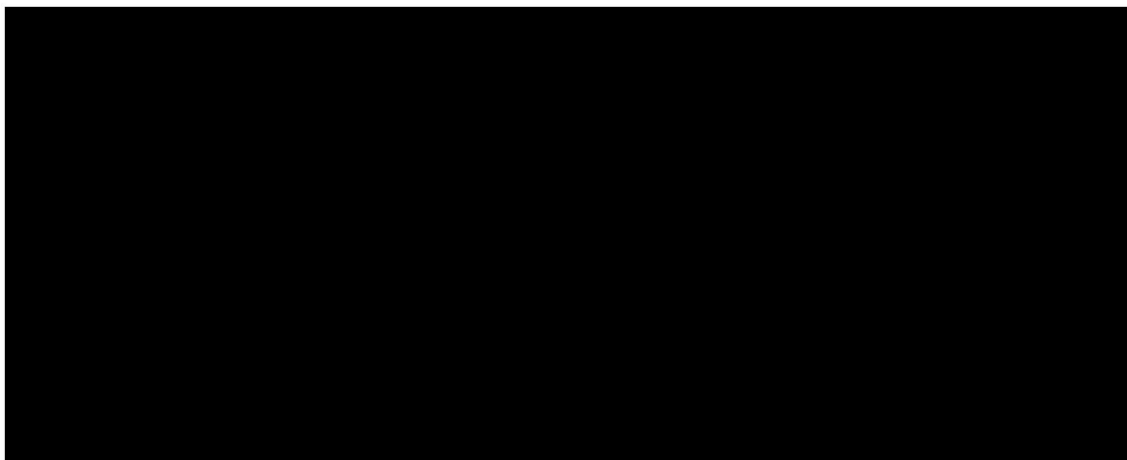

Dear Ms Quigley

Thank you for your email about this revised application. The new information does little to allay my original concerns.

If the plans went through, residents above and behind the premises wouldn't have a single day's respite from the constant comings and goings and activities of large numbers of people. It seems the applicant's strict observance of the sabbath does not extend to observing a day of rest for his neighbours.

I share the view, expressed in another comment, that the activities listed will likely be extended by other festivals and celebrations such as weddings, and bar- and bat-mitzvahs, with congregants spilling out onto the pavement.

In addition, the applicant's history of anti-social behaviour around rubbish (blatantly denied by the agent, despite all the evidence) doesn't inspire confidence that he would adhere to the terms of any planning permission in regard to hours and numbers.

I'm also concerned that the proposed use of the premises appears to have shifted from that of community centre to place of worship, which would be quite out of keeping with the rest of this parade of local businesses and shops.

I therefore continue to object to this application on the grounds that it would be inappropriate to the location and a source of nuisance to the local community.
