North Yard Shopfronts, Building AB, Stables Market, Camden, London, NW1
Application for Full Planning Permission (part retrospective)

On behalf of our client, Camden Market Estate Holdings Limited (the 'Applicant') we enclose an application for full planning permission at North Yard Shopfronts, Building AB, Stables Market, Camden, London, NW1 (the 'Site') for the:

"Replacement and installation of new shopfronts, including the installation of downlights and hanging and fascia, to the north, east and west elevations and replacement of existing gate [part retrospective]"

The application is being applied for retrospectively as the work to the shopfronts was started on 01 December 2019. The development has not yet been completed.

Relevant Planning History

On 25 October 2019 planning permission (ref: 2019/4714/P) planning permission was approved at Building AB for the following:

"Replacement and installation of new shopfronts, including the installation of downlights and hanging and fascia, to the north, east and west elevations and replacement of existing gate [retrospective]"

On 4 November 2019 planning permission (ref: 2019/4717/P) was approved at Building AB for the following development:

"The replacement of timber shopfronts of the Ground Floor retail units in the central section of the north elevation with glass and metal shopfronts and installation of awnings (retrospective)."

Site and Surroundings

The site subject to this application is solely the ground floor shopfronts in the western section of building AB. The works are proposed to the north, east and west elevations of this run of shopfronts.

The Site is located within the Regents Canal Conservation Area.

The Site is not statutory or locally listed, however, there are several listed buildings located within the Stables Market, including the Grade II Listed Provender Store and Grade II* listed Horse Hospital directly to the north of the site.

The Proposals

The proposal seeks planning permission for the:

"Replacement and installation of new shopfronts, including the installation of downlights and hanging and fascia signage, to the north, east and west elevations and replacement of existing gate [part retrospective]"

The details of the proposals are set out in the Design and Access Statement, prepared by LabTech.

The proposed design of the units follows the style of the previously approved shopfronts and retail units within in other areas of the building (ref. 2019/4717/P and 2019/4714/P). This application seeks approval for a new design of the remaining shopfronts in the north elevation of Building AB based on the principles previously applied.

The applicant has a vision to sensitively refurbish the heritage assets of the site whilst improving the later buildings and the visitor market experience. The proposals aim to provide vibrant new spaces and attract more visitors and contribute to the function and vitality of the wider Stables Market.

The proposals will not alter the quantum of existing internal floorspace at the Site.

Planning Policy

Section 38(6) of the Planning and Compulsory Purchase Act 2004, requires proposals to be determined in accordance with the statutory development plan unless material considerations indicate otherwise. The statutory development plan consists of:

- i. The National Planning Policy Framework ('NPPF') (as updated February 2019);
- ii. The London Plan, being the Spatial Development Strategy for Greater London (2016);
- iii. The Camden Local Plan (2017).

Relevant supplementary planning guidance for the site includes the Regent's Canal Conservation Area Appraisal and Management Strategy (2008).

Statutory Legislation

As the site is located within a conservation area, statute regarding the historic environment is relevant.

Section 66 of the Planning (Listed Buildings and Conservations Area) Act 1990 sets out that local planning authorities should pay special regard to the desirability of preserving a listed building or its setting or any features of historic or architectural interest which it possesses when considering applications.

Section 72 of the same Act states that special attention shall be paid to the desirability of preserving or enhancing the character or appearance of conservation areas.

Planning Assessment

Design and Heritage

Local Plan Policy D1 seeks to ensure development respects local context and character, preserves or enhances the historic environment and heritage assets, is of sustainable and durable construction and is adaptable to different activities and land uses and comprises details and materials that are of high quality and complement the local character. Local Plan Policy D2 seeks to preserve and, where appropriate, enhance Camden's rich and diverse heritage assets and their settings.

The design and materiality proposed to the North Yard Shopfronts will preserve and enhance the historical and industrial nature of the site and the wider Camden Stables Market. Furthermore, the proposed shopfront design will preserve and enhance the character and appearance of the setting of the Grade II* Horse Hospital which lies directly to the north of the site.

The proposals will also revitalise and reactivate this area of the market ensuring that the shopfronts remain an attractive, interesting and vibrant place to visit. This will contribute to the prosperity of the Stables Market thereby securing an important Camden heritage asset and its setting in the long-term.

Therefore, the design meets the statutory tests and accords with local plan policy in terms of heritage and design.

Shopfronts

According to Local Plan Policy D3, Camden expects a high standard of design in new and altered shopfronts.

When determining proposals for shopfront development the Council will consider:

- a. the design of the shopfront or feature, including its details and materials;
- b. the existing character, architectural and historic merit and design of the building and its shopfront;
- c. the relationship between the shopfront and the upper floors of the building and surrounding properties, including the relationship between the shopfront and any forecourt or lightwell;
- d. the general characteristics of shopfronts in the area;
- e. community safety and the contribution made by shopfronts to natural surveillance; and
- f. the degree of accessibility

The proposed design meets the requirements of the policy as the details and materials of the proposed shopfronts have been chosen to respect and reflect the character and appearance of the surrounding Stables Market, thereby maintaining the design relationship of the shopfronts throughout the market. The existing character of the site will be preserved and enhanced through the designs as the new frontages seek to improve the function of the shopfronts and seek to create a refined industrial aesthetic quality, in-keeping with the historic environment, without compromising the unique character of the market in general and the heritage assets in particular. Community safety and security in the area will be improved through the installation of downlights to the façade. The lights are discreet in design and are of a similar design to lights throughout the wider Stables Market. The existing level of accessibility is maintained in the proposals.

The proposed shopfronts therefore comply with Local Plan Policy D3.

<u>Amenity</u>

Lighting is proposed to be installed on the shopfronts. There will be a single downlight in between each unit. This will illuminate the only the spaces between the arches to enhance visitor experience, safety and security in the area, thereby ensuring there is no light spill into the surrounding area.

<u>Signage</u>

Camden's Advertisements CPG (2018) and Local Plan Policy D4 require all advertisements and signs should respect the form, fabric, design and scale of the host building and setting. All signs should ensure that they serve as an integral part of the immediate surroundings and be constructed of materials that are sympathetic to the host building and the surrounding area.

Local Plan Policy D4 states that Camden will support advertisements that:

- a. preserve the character and amenity of the area; and
- b. preserve or enhance heritage assets and conservation areas.

As with the existing shopfronts at the site, an area for signage has been included within the fascia of each of the proposed shopfronts. Hanging signs are also proposed to each shop.

The design of the signage is in keeping with the character and appearance of the conservation area and will ensure that the amenity of the area is preserved. The signs will have a consistent appearance across the shopfronts. White or light grey lettering will be surface mounted onto a black background for the fascia signage and hanging signs will have black lettering on a white background with bespoke font and logo applied to the panel.

The tenants will be required to utilise the proposed signage for advertisement as part of their lease. Therefore, the proposed signage and design is in line with Camden Local Plan Policy D4 and CPG.

Enhancing Existing Use

Furthermore, Local Plan Policy TC2 states Camden will seek to protect and enhance the role and unique character of each of Camden's centres and will seek to provide for and maintain, a range of shops including independent shops, services, food, drink and entertainment and other suitable uses to provide variety, vibrancy and choice. Local Plan Policy TC6 states that the Council will consider the character of the existing market when assessing proposals for the refurbishment and redevelopment of markets.

The proposals are in line with Camden local policies TC2 and TC6 as they will support and improve the continued function of the Site within the Stables Market. The refurbished shopfronts will enhance vitality and activity within the North Yard, preserving the character of the Site and contributing to securing its long-term future.

Conclusion

The development can be seen to preserve and enhance the character and appearance of the North Yard Shopfronts, whilst also contributing to the wider character and appearance of the Stables Market and the Regent's Canal Conservation Area.

The refurbishment of the Site will also secure the longevity and attractiveness of this part of the market in line with local policy TC6.

It is considered that the application complies with the relevant statutory tests, policies within the Camden Local Plan. It is further considered that there are no material considerations of sufficient weight to determine that the application is other than in accordance with the Development Plan, on this basis, planning permission should be granted for the application accordingly.
