Pascal-

I am still dealing with this application as I still have a few old ones to clear up.

The scheme has been revised following our comments so that the facade wash is reduced to 50%, the uplighters on the sides are omitted and the lighting is turned off at 11pm daily. It is worth pointing out here that the front façade lighting is merely replacing old floodlights that currently exist on a lamp column in the churchyard but have been non-operational for many years.

Accordingly we will be recommending this for approval and reporting it to a forthcoming Members Briefing panel in the light of objections received. I cannot give you a timescale yet as I am still awaiting formal comments from my conservation officer to incorporate into my report.
