Dear Occupier,

We are writing to inform you that the demolition of Aspen House, Maitland Park Gym and associated garages / sheds is due to start around mid-February 2020 and is expected to be completed around mid-May 2020.

This site will form part of Camden Council's partial regeneration of the Maitland Park Estate which will deliver new homes, new and improved community spaces, and landscaping improvements including new play provision. We are carrying out this demolition work ahead of the main works expected to start in the summer.

| What are the working hours on site? | 08:00 – 18:00 Monday to Friday 08:00 – 13:00 Saturday |
| How long will this work take? | The work will take approximately 14 weeks. |
| Which roads will be used to access the site? | Via Grafton Terrace into Maitland Park Villas and then to the site. |
| What types of hoarding will be used around the site? | 2.4m high timber hoarding around the boundary. |
| How will dust and noise levels be minimised around the site? | Dust will be controlled using high pressure sprays. Noise will be minimised through the use of low-noise level machinery. Noise, dust and vibration levels will all be monitored on site. |
| How will residents be kept safe from site traffic? | The site manager will be aware of all vehicles arriving or leaving the site, which will be guided |



| | by dedicated traffic marshalls. The site will enforce a strict 5mph speed limit. All vehicles will use the pre-determined routes of access and exit to avoid disruption. |

| Who will carry out this work? | A specialist demolition contractor will be appointed by Bouygues on behalf of the London Borough of Camden. Downwell have prepared the DMP and have been carrying out pre-demolition surveys and investigative works on site, however, the actual demolition works may be carried out by a different contractor. This will be confirmed ahead of the start of the demolition. |
