
Contrary to your email below, we were never 'consulted', despite being an immediate next door neighbour to the proposed development. No owner in my building ever received an invitation to the public meeting and we were completely unaware it had even taken place until a considerable time later. In a building of just 4 flats, where I invariably separate the post and work from home a lot, it stretches credibility to believe that we all missed both the flyers and in-person visits you claim to have conducted.

The only communication I ever received was when one of your colleagues saw a 'For Sale' sign by chance outside our property and contacted me via the estate agent in January. The feedback given to Camden Planning about our subsequent telephone conversations was in my view completely misrepresented and a wholly inaccurate characterization of our calls.

To present your client to Camden as a decent developer when the local community has had nothing but a cursory, superficial, box-ticking whitewash at the 11th hour, that is hardly worthy of being called a public consultation, is I believe both misleading and irresponsible.

I also find it very difficult to believe that the lightweight PR spin that was conducted adhered to the regulatory standards expected in a legitimate consultation process, especially for a huge development that will have such a profoundly negative impact on the local community. The guiding principles of a public consultation are transparency and inclusion from the beginning. This was opaque and divisive and in my opinion intentionally undertaken just weeks before the planning application was submitted to avoid any meaningful participation or scrutiny by neighbours.

It was simply a subjective exercise in confirmation bias to support the developer's commercial narrative and should be completely disregarded by Camden planning officials.
