The tree located in the SW corner of the front garden of 130 Belsize Road. It is a Lime tree which was previously managed as a pollard but currently has two full crowns, which has not been maintained for many years. I request approval to thin 10-20% while maintaining the well balanced shape. The inner branches are overcrowded causing dead wood, which falls during heavy rains and high winds.
