Proposed Work:

REAR GARDEN: 1 x London Plane (T2) - Crown Reduce by 25% .

1 x Ash (T3) - Crown Reduce by 25%.

5 x London Planes (T4 - T8) - Reduce back to previous pollard points.

1 x Holly (T9) - Crown reduce by 30% and remove overhang to neighbouring property back to boundary.

FRONT GARDEN: 1 x Sycamore (T10) - Crown reduce by 25%.

1 x Pyracanthus (T11) - Fell to ground level.

1 x Cherry (T12) - Crown reduce by 20%.

1 x Bay (T13) - Fell to ground level.

The Council has considered your notification of intended works to trees dated 13 March 2020 and does not wish to object.

- 1 This notice is valid for 2 years from the date of this letter or until the work is completed, whichever is the sooner.
- 2 You are advised that the appropriate standards for tree work are set out in BS 3998: 2010. Failure to ensure that the proposed works are carried out to these

standards may result in damage to the tree(s) and may result in legal action by the Council.

- 3 Please note that any approval given by the Council does not give an exemption from the requirements to comply with the Wildlife and Countryside Act 1981 (as amended), or any other Acts offering protection to wildlife. Of particular note is the protection offered to bats, birds and their nests from construction works.
