T1: Fig: Approximately 4.00m. Reduce height by 15% by means of removing non-fruiting branches only.

T1(B): Fig: Located behind T1. Reduce height by 20%.

Rear Garden:

T2: Acer - (adjacent stairway): Approximately 5.00m. Reduce extraneous branches back into main crown structure (approximately 15% reduction) to shape and balance. Thin crown density by 15%.

T3: Hornbeam: Approximately 9.00m. Reduce crown by approximately 30%.

T4: Holly: Approximately 6.00m. Reduce crown by approximately 20% to tidy and balance crown.

T5 & T6: 2 x Limes: Reduce lateral and sub-lateral branches of both trees which is growing into Holly by 1.00m.
