Hello - I am emailing you with regards to planning app 2020/1599/T.

I am emailing rather than sending a letter, as recommended, because I cannot print as I do not have access to a printer during lockdown, and according to the Council appeal website, I cannot use the online form for a tree related matter. Therefore, I am emailing you with my appeal to pass on to the relevant department. I do hope you will be able to do so.

The planning application regards a tree covered by a TPO. The application was put forward earlier this year. In the chaos of the lockdown, and being very busy with my work as a research scientist on COVID19, I can only now submit my appeal. As you can see from the attached correspondence, a decision regarding removal of the tree will be taken by June 1st.

The tree in question is a black poplar tree in the back garden of 91 Canfield Gardens; my flat in Greencroft Gardens backs onto the garden of 91 Canfield Gardens. It is a large and very beautiful tree which provides a lovely, heart-warming view for many houses nearby, and defines the personality of the area in all seasons. It also provides some privacy for the many apartments that face each other across the gardens. The apartments in at least 30 houses benefit from its beauty, and enjoy the variety of birds and other animals that visit daily; the tree is key to the local ecosystem. I am strongly opposed to the felling of this tree which is protected by a TPO, because of its value to humans and animals alike. It is important to protect mature trees such as this one in an urban area. Crucially, removal of this tree would irreversibly change the character of the area and affect the lives of many people that currently enjoy its presence every day.

My understanding is that the request to remove the tree is linked to a subsidence matter in the property where I live, 94 Greencroft Gardens, where I am one of 7 owners. The managing agent for this property has been working on our behalf with insurers to rectify the damage done by subsidence. However, the removal of this tree, as part of the strategy, is not supported by all 7 owners, and the action to file the application was carried out without informing the owners.


I have attached the correspondence from the council related to the tree and a picture of the tree.




